Goal 1: Create dynamic partnerships among service providers, researchers, advocacy groups, commissions, educators, responders, and policy makers to improve services to vulnerable and abused elders, share practices, and coordinate response systems.

- Organized committee to improve coordination in abuse report investigations. The
 group includes Mark Sellers, Chair of the Protective Services Operations Committee
 of the California County Welfare Directors Association; Long-term Care
 Ombudsman Joe Rodrigues; Brooke Hollister, University of California, San
 Francisco; Kris Brown, Area Agency on Aging Napa; and Aileen Wiglesworth,
 University of California, Irving.
- Conducted statewide survey of Adult Protective Services and Long-Term Care Ombudsman Program staff to gain better understanding of jurisdictional issues encountered across California.
- Assisted Julia Wysong, Coordinator of the coalition of Financial Abuse Specialist Teams (FAST), plan and convene meeting to solicit input on financial abuse and exploitation trends, and identify policy and service needs.
- Make monthly reports on CEJW and solicit input at meetings of the Protective Services Operations Committee (PSOC) of the California County Welfare Directors Association (CWDA).
- Launched group to explore Victims of Crime Act (VOCA), California restitution fund, and other potential sources of assistance and compensation for elderly victims.
- Facilitated participation by legal service professionals on California Medical Association work group revising California's Capacity Declaration form.
- Facilitated collaboration between the Statewide APS Training Project, PSOC, and the California State Association of Public Administrators, Public Guardians, Public Conservators for an advanced training series on client decision-making capacity for APS and PG employees.

Goal 2: Create mechanisms and opportunities for information sharing, discussion, problem solving, consensus building, collaboration, and collective advocacy. Identify unmet needs for services and policy, and recommend promising solutions.

- Planned and organized statewide summit of 92 APS workers, public guardians, judges, attorneys, victim advocates, researchers, educators, legislative staff, trainers, Ombudsmen, and other stakeholders to formulate recommendations for the future direction of services and policy.
- Organized Technical Advisory Group (TAG) with 17 members.
- Collaborated with the Center of Excellence in Elder Abuse and Neglect at the University of California, Irvine (UCI) to explore salient issues identified by projects supported by the Archstone Foundation Elder Abuse and Neglect Initiative.
- Created a database of stakeholders, including policy makers, researchers, media, university faculty, representatives from professional associations, and opinion leaders (currently includes 236 people).

- Launched CEJW-Discuss Google Group to facilitate information-sharing among CEJW staff, Steering Committee members and stakeholders, and to exchange feedback on draft Blueprint materials.
- Serve as partner in California Association of Area Agencies on Aging Annual Conference. Organized four workshops and panel with other stakeholder groups.
- Published article on CEJW in the *Journal of Elder Abuse & Neglect*.
- Submitted proposals to present at the American Society on Aging conference in 2011 on statewide summits, coalitions, and policy initiatives; and promising practices in financial abuse prevention.
- Facilitated session at the statewide Long-Term Care Ombudsman Program conference to gain input for the blueprint and disseminate information about Statewide Elder Abuse Summit and CEJW.

Goal 3: Disseminate information and offer recommendations to service providers, policy makers, program developers, academic institutions, advocacy groups, and foundations to ensure that abuse prevention services and policy meet critical needs and are informed by research and practice experience.

- Developed *Mental Health Service Needs of Vulnerable Elders: A Fact Sheet* to help members of the elder abuse prevention network understand the Mental Health Services Act (MHSA) and advocate on behalf of abused and vulnerable elders. The fact sheet describes specific opportunities provided under the Act as well as unmet mental health service needs including services for elders who have experienced catastrophic losses as a result of financial exploitation.
- Explored discrepancies in how APS units across the state and nationally define eligibility and disseminated findings at state and national conferences to stimulate discussion about the need for greater clarity and uniformity in APS response.
- Conducted environmental scan to identify and review the findings and recommendations of previous statewide initiatives.

Goal 4: Provide leadership and support to program and policy development at the state, national, and international levels by providing testimony, recommendations, informational materials, analysis, and expertise.

- Developing blueprint (in progress) for a sustained, proactive, and coordinated approach to advocating for services and policy.
- Provided testimony to the California Department on Aging (CDA) in the development of its Five Year plan. Recommendations for how CDA can expand its capacity to prevent abuse included encouraging senior centers to develop policies to prevent proprietary or predatory salespersons who pose as objective financial advisors from making presentations, providing training on complex and emergent forms of financial abuse to legal services providers, and encouraging caregiver support programs to screen for high risk situations. The group has offered to provide information and technical assistance to CDA in implementing these measures
- Responded to request for stakeholder feedback on MHSA suicide prevention, and stigma and discrimination reduction priorities.
- Submitted list of legal issues to the Administrative Offices of the Courts.
- Provided testimony to the Administration on Aging on the Reauthorization of the Older Americans Act.
- Developed criteria for evaluating policy related to the investigation and response to abuse in long term care facilities in California.
- Provided testimony at Oversight Hearing: The Long-Term Care Ombudsman
 Program--Protecting the Protectors of California's Most Vulnerable Adults. The
 hearing, hosted by Assembly Member Yamada, Chair of the Assembly Aging and
 Long-Term Care Committee, addressed the impact of budget cuts on the Long Term
 Care Ombudsman Program (LTCOP), elder and dependant adult abuse reporting
 responsibilities, and state and federal LTCOP responsibilities.
